| District Contact Your child MUST be registered with your home district before registration is complete. Parents must call the district and inform them that your child will be attending St. John. You will be given a packet to complete and return. Ideally this should be completed by the end of July. |
| Bison Fund or Tuition Assistance (if needed) Tuition help is available to families through the <u>Bison Fund</u> . To see if your family is eligible, visit www.bisonfund.com . A pre-application can be submitted online at http://bisonfund.com/our-scholarships . All applications must be completed online no later than March 15, 2024. The Bison Fund can pay up to 75% tuition per student. |
| St. John Tuition Assistance Applications are available from the office. Please note that families should first apply to Bison Fund. St. John tuition assistance is funded fully on individual donations and is divided according to need. All applications must be submitted by April 10, 2024. |

OPTIONS FOR PAYMENT

- 1) **Full Payment Discount Plan:** Cash or check must be submitted to the office no later than July 5, 2024, to receive a 2% discount on tuition.
- 2) **Four Quarter Payment Plan:** Cash or checks must be submitted to the office no later than August 12, 2024, November 12, 2024, February 12, 2025, & April 14, 2025. See the tuition policy for late payment fees.
- 3) **10-Month Payment Plan:** Deducts tuition payment automatically from a checking, savings, or credit card account each month, **August May**. An Authorization form must be filled out and turned in, no later than July 24, 2024. A 2% non-refundable enrollment fee is added to the first of the 10 monthly payments for enrollment in this option. See tuition policy for late payment fees.

BISON FUND:

Tuition help is available to families through the <u>Bison Fund</u>. To see if your family is eligible, visit <u>www.bisonfund.com</u>. A pre-application can be submitted online at <u>http://bisonfund.com/our-scholarships</u>. All applications must be completed online no later than March 15, 2024. The Bison Fund can pay up to 75% tuition per student.

TUITION ASSISTANCE:

Members of St. John Lutheran School Board of Christian Education seek to provide a Christian Education to all children. Therefore, a tuition assistance program has been developed under the direction of the Tuition Assistance Committee. All families should apply to the Bison Fund before the Tuition Assistance Fund.

This application is to be filed by **April 10, 2024**. Applications will be reviewed by the Tuition Assistance Committee in a confidential manner. The committee <u>will not</u> review the tuition assistance application until a signed copy of both sides of the parents' 2023 and/or the student's 2023 Federal Income Tax returns are received.
